Read Luke 11:42

Read Matthew 23:23-24

23 "Woe to you, teachers of the law and Pharisees, you hypocrites! You give a tenth of your spices—mint, dill and cumin. But you have neglected the more important matters of the law—justice, mercy and faithfulness. You should have practiced the latter, without neglecting the former. 24 You blind guides! You strain out a gnat but swallow a camel.

- What criticism does Jesus make about how the Pharisees approach tithing?
- Why does Jesus say that tithing is not enough on its own?

- What does Jesus mean by "Do the latter without neglecting the former"?
- How does the passage describe the difference between tithing as a mechanical action and tithing done out of love for God?
- Why is it significant that Jesus did not discard the practice of tithing when he had the opportunity?
- What message does Jesus want to emphasize instead of rejecting tithing?

Leviticus 27:30

A tithe of everything from the land, whether grain from the soil or fruit from the trees, belongs to the Lord; it is holy to the Lord.

- What were the primary purposes of the tithe?
- Why is the concept of a 10% tithe important in understanding God's expectations for His people?
- What does it say about our faith when we are willing to give the first 10% back to God?
- How does the generosity of God in allowing His people to keep 90% of the crop demonstrate His care for them?
- What is the "deal of a lifetime" Kyle described?
- How does the analogy of the modern-day VRBO scenario Kyle mentioned help illustrate the concept of the tithe?
- What does Jesus' stance on tithing suggest about its continued importance in the life of faith?
